If a producer, processor or cottage industry, I understand and agree that:

- I reside and/or own property in Tuolumne County.
- All agricultural products marketed under the Farms of Tuolumne County logo are grown in Tuolumne County.
- All processed agricultural products marketed under the Farms of Tuolumne County logo contain a minimum of 60% ingredients that are grown in Tuolumne County.
- Farms of Tuolumne County promotional materials including the logo are restricted in use to producer and corporate members in good standing.
- Permission to use the Farms of Tuolumne County promotional materials including the logo can be withdrawn by a vote of the Farms of Tuolumne County Board of Directors for failure to adhere to the membership agreement.
- The Farms of Tuolumne County membership year is January 1 through December 31 in each calendar year.
- Membership benefits including the use of the promotional materials and logo are designed for one (1) membership year only.
- Membership must be renewed annually to receive continued benefits
